# 1. About the Policy.

This policy explains when and why we collect personal information about our members, how we use it and how we keep it secure and your rights in relation to it.

We may collect, use and store your personal data, as described in this Data Privacy Policy and as described when we collect data from you.

We reserve the right to amend this Data Privacy Policy from time to time without prior notice. You are advised to check the Club website regularly for any amendments (such amendments will not apply retrospectively).

We will always comply with applicable UK Data Protection legislation including GDPR when dealing with your personal data. For the purposes of GDPR, we will be the "controller" of all personal data we hold about you.

## 4. How we protect your personal data.

We have implemented general accepted standards of technology and operational security in order to protect personal data from loss, misuse, or unauthorized alteration or corruption.

We will notify you promptly in the event of any breach of your personal data which might expose you to serious risk.

## 5. Who else has access to the information you provide us?

We will never sell your personal data. Apart from British Canoeing who may require Club membership details and qualification, we will not share your personal data with any third parties without your prior consent (which you are free to withhold) except where required to do so by law.

# 6. How long do we keep your information?

We will hold your personal data on our system for as long as you are a member of the Club and for as long afterwards as is necessary to comply with our legal obligations.

# 7. Your rights.

You have rights under UK data protection law, including:

- 1. To access your personal data.
- 2. To be provided with information about how your personal data is processed.
- 3. To have your personal data corrected.
- 4. To have your personal data erased in certain circumstances.
- 5. To object to, or restrict, how your personal data is processed.
- 6. To have your personal data transferred to yourself or to another Club in certain circumstances.

If you wish for us to erase your data as outlined in paragraph 4 above then please contact the membership secretary at herefordkayakclub@outlook.com. Please be aware that if you are a current member of Hereford Kayak Club deletion of your personal data will lead to immediate termination of your membership.
