The weather was good and attendees enjoyed a wonderful day catching up with past and present members, eating, indulging in pleasure paddling, K4 paddling and competing in some very competitive Tempest sprint challenge.

Kay & Tony put together an excellent display of photographs taken over the 50 years which caused much discussion and memory recalls for all the attendees.

At the end of the day, we presented Kay & Tony with a pictorial map of the local water, in thanks for the dedication and support that they have both given to the Club over many years.

Time trials have been held throughout the year and the recorded times can be found on the Club website.

The recasting of the lower steps, noted at last year's AGM was completed and we wait to see how long it will last.

Regarding the proposed installation of the boat crane, we do not currently have an update on this project.

The three boats that we ordered from Kirton Kayaks and Marsport were received and have been well used since their arrival.

And finally, two crews representing Hereford competed in DW this year. Mike and Sam in C2 pulled out at Marsh due to illness. Rob and John completed the race finishing in 10th place in the Civilian race and 3rd place in the Veteran Class Well done to them.
